Dear Parent/Guardian,

Alan Shawn Feinstein Middle School of Coventry has finalized plans for our annual 8th Grade Outing which will take place on Friday, June 9, 2017.

The location of the outing is the High Meadow Resort in Granby, CT. The day will include a disc jockey with music, dancing and contests (lip sync, limbo, etc.), the awesome rock wall, heated pool with diving board and miniature golf. Activity directors will run events and games including, but not limited to, hot shot basketball, ping pong, wiffleball, capture the flag, egg toss, softball, pie eating contest, sack races, 3 on 3 basketball and pool games. Prizes will be given to all game winners. There will also be surprise carnival attractions. The price of transportation is factored into the overall cost. Horseback riding is the only activity which requires an additional fee. The buses will leave ASFMS at approximately 7:00 am and return at approximately 6:15 pm. Transportation to school and home from school will need to be provided.

The cost of the outing is \$64.00 and can be paid in full or in two installments of \$32.00 each. The first installment will be due on or before March 10 and the second installment will be due on or before May 5.

If your child is interested in attending the 8th Grade Outing please fill out the permission slip on the reverse side of this notice and return with the initial payment of \$32.00 by March 10. Permission slips and payments should be brought to the Main Office (there will be a collection box there). Checks should be made out to Feinstein Middle School or ASFMS.

Any student whose total number of suspension, ALC and detention hours is equal or greater than a ten day suspension may be disqualified, or within 45 days of the trip a student may be removed for any suspension or ALC placement or two or more failures.
